Statements dated on the 1<sup>st</sup> of the month are due no later that 8:30 am on the 16<sup>th</sup> of the month. (I.E Statements dated 9/1/10 will be due 9/16/10)

**Late payments to tuition and/or childcare cost will incur a 5% late fee. Returned checks will incur a \$35 fee.**
